There are two forms you will have to provide certain identification for in order to work on show. Without these, you will not be able to work. Fed I-9 and State Proof of Residency.

The first time you go to a wardrobe fitting, you will need to be prepared with the following. **If** for some reason you are not required to go to wardrobe before your first shoot date, the docs must be taken with you to the set.

### **Federal I-9 Form**

This is required by the Fed Government to prove that you are a legal citizen of the United States. A production representative will provide you with this form and need to see the following ID in order to sign off on I-9. You must bring these forms of id with you!!!!

### **Adults I-9 Form,**

Option A) Current Passport

Option B) Requires **two** types of ID as follows: You must bring one from *each* group listed.

**One** of the following:

- 1) State Issued Drivers license,
- 2) OR school ID with photo
- 3) OR voter's registration card.

**AND**

**ONE** from this group:

- 1) Social Security Card
- 2) OR Birth Certificate

Most commonly used combo for I-9 is DL and SS Card.

### **Minors I-9 Form**

**ONE** from this group:

- 1) School Record or Report Card
- 2) OR Clinic, Doctor or Hospital Record
- 3) OR Day Care or Nursery School Record

**AND**

**ONE** from this group:

- 1) Birth Certificate
- 2) OR Social Security Card.
- 3) **PLEASE BRING YOUR CHILD'S SOCIAL SECURITY CARD**

Most commonly used combo for Minors is School or Clinic record with Birth Certificate

### **AR Proof of Residency**

This form is attached to this website. You will need to take a COPY OF YOUR DRIVERS LISCNSE TO ATTACH TO THIS FORM. For minors, the parent's copy of DL will work. Again, for this form you need to bring a copy to leave with form!!

State of Arkansas
DECLARATION OF RESIDENCY
For Production Rebate

Purpose of this form. Production companies claiming a rebate based on wages or salaries paid to Arkansas residents for work performed on a project in Arkansas must have each employee complete this Declaration of Residency form. Please enclose a completed form for each resident with the Proof of Performance

Form with fields: Employee Number (Must correspond with employee number on Payroll Rebate Calculation Worksheet), Name, Social Security Number, Permanent Residence - Physical Address, City, State, Zip Code, Phone Number, Title of Project

- 1. Are you presently a resident of Arkansas? See "Residency" below.
2. Do you anticipate changing your residency status during the time that you are expected to work on the project?
3. What evidence have you provided the production company to show residency in Arkansas?
You must have at least one of the following:
- A valid Arkansas driver's license. (Please attach copy)
- A current Arkansas voter registration. (Please attach copy)
- A copy of last year's Arkansas personal income tax return.
- Other: Indicate type. If you cannot provide one of the previous three forms of evidence, other evidence may be acceptable.

Residency. To be a resident of Arkansas for tax purposes you must be domiciled in Arkansas, maintain a permanent residence within the state and spend at least six (6) months of the taxable year within the state.
